Release and Waiver of Liability and Indemnity Agreement

IN CONSIDERATION of applying for, or renewing, my/our membership in the Peninsula Ski Club ("PSC"), the undersigned for himself or herself and his and/or her children, and any personal representatives, heirs and next of kin, hereby enters into this Release and Waiver of Liability and Indemnity Agreement.

The undersigned acknowledges, agrees and represents that he or she has inspected, or immediately upon entering will inspect, the PSC lodge located at 10053 Lake Angela Drive, Norden, California (the "Lodge"). IN FURTHER CONSIDERATION of being permitted to enter and use the Lodge for any purpose, the undersigned hereby agrees to the following:

- 1. - 3. The undersigned hereby ASSUMES FULL RESPONSIBILITY FOR AND RISK OFBODILY INJURY, DEATH OR PROPERTY DAMAGE to the undersigned or such children due to the negligence of Releasees or otherwise while in, upon or about the Lodge, or traveling to orfrom the Lodge.

THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of California.
